


Message from the Executive Director

About the Australian National Botanic Gardens







A living collection like no other

The Australian National Botanic Gardens is the world's most comprehensive display of living Australian native plants. With over 6,000 species representing one-third of known Australian plants, the Gardens is the only place in the world you can see this diversity of Australian native plants in one location.

Spaning 40 hectares of water-wise, sustainably managed gardens, the Australian National Botanic Gardens' collection includes over 70,000 plants.

Collected over the last five decades, the plants range from coastal regions, alpine meadows, tropical rainforests to dry deserts.

A world-leader in research

The Australian National Botanic Gardens has a strong international reputation for scientific and horticultural research and often works collaboratively with leading institutions.

The Australian National Botanic Gardens' partnership with CSIRO at the Centre for Australian National Biodiversity Research, for example, fosters vital work that enhances knowledge, conservation and sustainable use of Australian flora.

The Centre houses the Australian National Herbarium, a leading research institution for the naming and

classification of Australian plants, which holds a collection of over 1.4 million specimens.

The Australian National Botanic Gardens also plays an important role as part of the national biodiversity safety net through our Seed Bank.

An inspiring place

From cleared dairy farms at the foot of Black Mountain to a much-loved national institution, the Australian National Botanic Gardens welcomes close to half a million people from across the nation and around the world every year.

Of these visitors, more than 12,000 students throughout Australia come to take part in environmental education programs, fostering an understanding and an appreciation for Australia's native flora.

Management

The Gardens are managed by the Director of National Parks – a Commonwealth Statutory Agency established to manage Commonwealth reserves such as the Australian National Botanic Gardens. The Director of National Parks is governed in accordance with the Commonwealth Authorities and Companies Act 1997 and relevant government policies.





What is a bequest?







A bequest is a gift made through a Will. It is a way to give tangible support to what you value and to leave a lasting legacy in your memory.

A beguest helps us to realise the long-term vision for the Gardens, enabling us to:

- · expand the living collection by developing new gardens
- engage in new research projects
- increase our conservation efforts
- share our knowledge more effectively
- deliver new education and public programs

We direct bequests to where they will provide the most benefit, but you may wish to nominate a specific purpose for your beguest. If so, we encourage you to contact the Australian National Botanic Gardens General Manager for a confidential discussion about your preferences and ideas.

Importantly, the Australian National Botanic Gardens manages and accounts for all proceeds of bequests, in accordance with Commonwealth Government guidelines, ensuring that funds are directed to the purpose for which they were provided.

The Ducrou Pavilion

The Ducrou Pavilion on the **Eucalypt Lawn was made** possible through a generous bequest from Anne Ducrou. The Pavilion features a series of roofs supported by columns of abstract 'trees', which help reinforce the importance of real trees to the Gardens' landscape. Opened in 1999, the pavilion continues to be a popular venue for picnics and is often used for special events.





Types of bequests







Bequests can be on any scale and may involve:

- · a sum of money from your estate
- · a percentage of your estate
- a specific asset, such as shares and life insurance or other possessions including documents and academic papers
- a residue of your estate after family and friends have received their gifts and provision has been made for all duties, debts, probate and testamentary expenses from your estate.





Making a bequest







The following draft clauses are intended only as a guide, for the reference of your solicitor, and we encourage you to seek independent legal advice in preparing or amending your Will.

Draft wording for an unrestricted bequest

I give the Director of National Parks trading as the Australian National Botanic Gardens, GPO Box 1777, Canberra, ACT, 2601

Specify either

- a. the sum of cash;
- b. shares, property, other assets or possessions;
- c. the percentage of the estate; or
- d. the percentage of the residue of the estate

free of all duties, debts, probate and testamentary expenses, to support the activities of the Australian National Botanic Gardens. I direct that the receipt of the Executive Director of the Australian National Botanic Gardens or their delegate shall be full and sufficient discharge to my Executor or Trustee.

Draft wording for a specific bequest

I give the Director of National Parks trading as the Australian National Botanic Gardens. GPO Box 1777, Canberra, ACT, 2601

Specify either

- a. the sum of cash:
- b. shares, property, or other assets;
- c. the percentage of the estate; or
- d. the percentage of the residue of the estate]

free of all duties, debts, probate and testamentary expenses, to be used for

If that purpose is not available for whatever reason, I request that my gift be applied in a similar field or for such other purposes as the Australian National Botanic Gardens determines in its sole discretion are most closely in accordance with my directions. I direct that the receipt of the Executive Director of the Australian National Botanic Gardens or their delegate shall be full and sufficient discharge to my Executor or Trustee.
